

Navigating the complexities of the National Council on Compensation Insurance (NCCI) class codes can be challenging, especially when ensuring accurate classification for workers' compensation insurance. Misclassifications can lead to significant financial implications for businesses.

Many carriers, especially in this competitive workers' compensation marketplace, have not used the correct code for years, meaning the e-mod will show the incorrect code that many underwriters will follow. Some states, including Indiana, require a class code inspection before changing the class codes or governing code. They rarely, if ever, retroactively apply the correct code.

Additionally, many insureds don't keep detailed enough records to separate codes, so carriers lump all into the highest-rated code. If it's multi-state, and the insured doesn't keep payroll records by state and runs it all through the domiciled state, then it goes into the highest-rated state/code. In this situation, things can get ugly fast. Different rules apply to assigned risk and residual markets in some states.

Premium audit is one of the more difficult aspects of our job and for some carriers, it's a big enough reason to lose renewals or even lose business midterm. When premium audits go into dispute and drag out, they end up in collections, and those involved lose commission.

Here are some commonly misclassified NCCI class codes with comparisons to help clarify their proper usage:
